2 The Scheme is looked by a Board named Ayurveda Training Accreditation Board (ATAB) housed under RAV.

3. For operationalization of the scheme a pool of Assessors is required. These Assessors are Assessment Peer Reviews who conducts Audit/ Assessment on behalf of ATAB/ RAV and submit reports to ATAB/ RAV.

How to Become ATAB Assessor (Quality Enhancement Initiative for Ayurveda Training Courses)

A candidate has to attend 3 days Assessor Training program on accreditation standard and meet the following educational & experience requirements

Following can apply for a 3-day assessor training program.

Eligibility Criteria for 3 Day Assessor Training Course		
A.	Qualification	MD/ MS in Ayurveda
B.	Training	– preferably having prior knowledge of Accreditation, and training in auditing.
C.	Work Experience –	15 years after MD/MS for lead assessor and 10 years after MD/MS for assessor
D.	Audit Experience – (only once empanelled as a auditor/assessor or lead auditor/assessor.)	At least 5 mandays of audits as trainee to qualify for auditor/assessor and at least one audit as a lead auditor/assessor under the supervision of another lead auditor/assessor to qualify to be lead auditor/assessor.
