Note:

1. The fee is exclusive of GST. As per the GOI guidelines, a GST at the rate of 18% is applicable.
2. Fees will be calculated as per the number of courses applied.
3. Fees to be paid through Bank Transfer/NEFT/Internet banking/UPI etc.
4. The Training provider must upload the proof of the transaction on the ATAB Portal with the following details:
 - a) UTR Number/ Transaction Id
 - b) Date and time of transaction
 - c) Amount of transaction
 - d) Applicant's name
 - e) Institute name
 - f) PDF copy of the transaction.
5. The accreditation application fee does not include expenses on travel, lodging/ boarding of assessors, which will be borne by the training provider/Assessee Institute only.
6. Travel of the Assessor and Lodging of the Assessor/ Moderator and Observer will be borne by the Assessee Institute.
7. The application fee includes Desktop Document Assessment (DDA) charges.
8. The annual fee for the first year is payable after the successful completion of the Desktop Document Assessment (DDA) and before the onsite/ virtual/ hybrid assessment visit. For the consecutive years of validity, the annual fee will be payable one month before the validity period. Before renewal assessment also, the forthcoming annual fee will be payable in advance.
9. A 10% discount will be admissible in case the Training provider pays the accreditation fee for three years in advance in one instalment at the start of the accreditation cycle.
10. The annual fee has to be paid by the Training provider in advance and it includes assessment charges/ charges for surveillance.
11. The Application fees/ Annual fees/ Manday charges etc. once paid shall not be refunded, in any case, even if the decision of ATAB on the Training provider application is unfavourable.
12. Fee once paid is non-refundable and non-transferable, in any case, to the Training provider.
